Clemenceau and de Vreziéneuil differed over how to apply the law to crime, both based on Catholic doctrine. In response to de Vreziéneuil's advocacy for "toleration" or "a just regard for those who do not wish to commit or to continue to commit these acts", Clement XIII (whose name is also credited to de Vreziéneuil's son) declared the right to life of all citizens of the state to be absolute. The only time the Church had recognized persons as criminal was if they "undermine or take part in other kinds of crimes" (Article I, 7). De Vreziéneuil understood that "the crime of murder" was not a crime, that it was "a great moral evil." Although the right to life was always an absolute value, De Vrezer said, "it can not be defended upon the ground that the criminal, with his life, is to be treated in this way because he is a criminal". His opponents, who argued that it was an abuse of power, often said that people could be sentenced to capital punishment for crimes which were no longer punishable under law. However, the Church has never endorsed the notion of mercy. Allowing such a punishment would be inconsistent with Catholic doctrine.. . Ludovic de Vreziéneuil (1899-1941) This article is an excerpt of a longer work, The Laws of the Republic. He argued for liberal principles at a time when some conservatives felt they were justified by the monarchy, which de Vreziéneuil viewed as a symbol of national pride and independence. The liberal principles underlying the republican structure of the Roman Catholic Church provided for government by magistrates rather than kings. For de Vreziéneuil, the law of the Republic meant less liberty and was not necessarily more freedom. He thought the civil rights of men should remain equally valid for everyone, except those who were under the rule of another authority, and he did not approve of the death penalty..
